SUBJECT: POLARIZED TWO (2) WIRE PLUGS/CORD SETS

22-64-0215 120 18 2 SJ 8 CORD SET

TO COMPLY WITH A RECENT CHANGE IN THE NATIONAL ELECTRICAL CODE (NEC) REQUIRING POLARIZED PLUGS ON DOUBLE INSULATED TOOLS WITH SINGLE POLE SWITCHES, ALL METCO TWO (2) WIRE CORD SETS ARE CURRENTLY BEING CHANGED TO INCLUDE A POLARIZED PLUG. POLARIZATION IS A MEANS OF ASSURING THE MATING OF PLUGS and RECEPTACLES IN ONLY THE CORRECT WIRING ARRANGEMENT - BLACK TO HOT & WHITE TO NEUTRAL.

THE CHANGEOVER TO POLARIZED TWO WIRE CORD SETS ON TOOLS AND TO SERVICE REPLACEMENT PARTS INVENTORY WILL BE COMPLETED BY SEPTEMBER, 1991. NO CHANGE TO CURRENT TWO WIRE CORD SET PART NUMBERS WILL TAKE PLACE.

NOTE:

ALL HIGH SPEED DIE GRINDERS, 4-1/2" & 5" SANDER/GRINDERS, BODY GRIP JIG SAWS, SHEARS and NIBBLERS WIRED WITH A 22-64-0215 CORD SET and THE 23-66-1170 OR 23-66-1190 SWITCH IN A "SINGLE POLE" SWITCH CONFIGURATION MUST BE WIRED AS SHOWN ON WIRING INSTRUCTIONS BULLETIN 58-01-0306 OR 58-01-0308.
